


PRESIDENT'S MESSAGE

_DAVE **HUMPHREYS** *HBPOA President*

I hope everyone enjoyed the holiday and recent New Year finding some quality time with their loved ones. This is a time when we customarily share a traditional meal with our families in celebration of the season and the opening of our hearts to others. I wish for everyone a happy and healthy New Year with success and future accomplishments in 2017.

More than likely, we have all cast our recent New Year resolutions after reflecting on this past year. From that, we have likely contemplated or created new goals. Achieving them, well, that's another story. Some of these perennial goals that we set are often insurmountable. The best practice is to be specific, measurable, attainable, realistic, and time-sensitive. Be practical and realistic. Focus on how you can make your newfound aspirations a reality this year.

I have heard many suggest that 2016 was a particularly disastrous year; perhaps the worst year ever. I must say, I have personally evaluated 2016 and felt it to be one of the worst years for law enforcement. In February 2016, Case County Sheriff (North Dakota) Paul Laney said, "People are hunting us. How do you think that sits with us?" Our casualties were great and there was a considerable spike and surge in the number of officers shot, killed, and ambushed compared to the past few decades. The attacks in Dallas and Baton Rouge, for example, police officers encountered suspects with military training. These types of events will continue to elevate public safety concerns and make it much more deadly for law enforcement professionals. Nationwide, we lost a total of 140 officers last year.

During these difficult times, California law enforcement continues to maintain many vacant positions. These levels are substantially higher than normal. Many police agencies are facing hiring shortages. In the past 5 years, law enforcement openings in California have increased more than 600 percent. Several police officers have separated from



the craft for the private sector. Others have left sooner than they originally projected for retirement. The social climate has had a looming consequence and agencies are now faced with uncovering reliable and dependable applicants, which are becoming more arduous. Furthermore, a constant need to maintain public safety and to generate effective recruiting sculpturing the ability to retain qualified personnel.

The most effective way to combat crime and deter recidivism is having a well-staffed police department. An increased demand for local law enforcement professionals was shaped through the passage of Proposition 47. Many theft and narcotic crimes are now inconsequential misdemeanors. Proposition 57 will only exacerbate these ongoing needs for officers. The Rand Corporation completed an exhaustive research on the cost of crime and the effectiveness of police services in preventing crime. The return on investment for hiring additional officers is likely to be appreciably above the cost of hiring. The Public Policy Institute of California (PPPIC) agreed with Rand.

Much anxiety and apprehension has been voiced by many different city officials and the general public surrounding the pension issues for law enforcement personnel. The current discernment is how CalPERS does business. Some believe that taxpayers fund the total cost of public pensions. This is not true. CalPERS investment earnings pay the majority of the public pension costs. For example, from 1997 to 2016, data shows that for every dollar CalPERS pays in pensions, 62 cents comes from CalPERS investments. Another 25 cents per dollar are paid by employers and the members themselves pay about 13 cents per dollar.

Although CalPERS returns have fallen short of their annual return target as of late, other public pension funds have also missed their mark. CalPERS is approximately \$300 billion strong. All public employees who are CalPERS members pay into their pensions. Every month, members contribute a certain percentage of their earnings towards their pensions. Through collective bargaining, agreements are negotiated between various labor groups with their

employer. Currently, California state employees are paying the highest rates and some up to 15% of their income.

Our labor group will soon be going back to the table - a time to draft labor peace with a balanced conclusion of fair and competitive wages and improved working conditions. The majority of law enforcement personnel depend on equitable salaries, better health care and stable pensions. We too need to stay competitive in an effort to recruit and retain qualified personnel, which is already a difficult challenge. Turnover is costly in terms of training and the loss of tenured experience. One way to enhance retention is to augment viable compensation and benefits and overall packages that will attract qualified personnel and retain those that we have.

It is unfortunate, but the peaceful and untroubled days of negotiations are long gone. Police associations, despite their best efforts at the bargaining table, have often found themselves preparing for pay and benefit cuts and more restrictive working conditions. State, county and city leaders are trying to fight back against associations and organized efforts to weaken public sector associations or unions. Their goal is often to eliminate collective bargaining rights, and end defined benefit pensions and civilianize many law enforcement jobs.

Many police associations have been forced to change the way they do business for enhanced survival. The Huntington Beach Police Officers' Association (HBPOA) has and will continue to identify effective communication with or through our political resources, partners, council members and others to work through the complexities and confrontations that often occur in this arena. A common goal, with most every issue, is the ability to work together reaching common vision and universal goals.

A recent fiscal health study was conducted on 116 different cities within the United States and those with a population over 200,000. Much of the data used were financial reports issued by the cities themselves. The City of Huntington Beach fell into 4th place in this study. Different factors such as general fund balance compared to expenditures, ratio of long-term obligations to total government-wide revenues and actuarially determined pension contributions to revenues. The city seems to be rather healthy and we are extremely thankful for that. The City of Huntington Beach is running a financially stable race around the municipal track.

The HBPOA is hopeful to elevate our police department this year. It is time to enhance our infrastructure, our equipment, records management systems, security and overall working conditions. An investment venture can only inspire and attract other law enforcement professionals to become a part of our team as we continue down a path with position shortages and ongoing loss of personnel through attrition.

Well, rest assured you did not miss anything as it was not published. There were some issues that prompted the canceling of that publication, the first since 2000. However, many of those items were included in this issue.

HB 9/11 MEMORIAL DEDICATION

TO HONOR THE PAST, TO SERVE THE PRESENT AND SECURE THE FUTURE



Chaplain's Corner

(Luke 22:26)

TO PROTECT AND SERVE

To serve and protect is part of the mission of all police agencies, but what does it really mean to be a servant and to serve. Like most people, we seem to be always jockeying for position and striving for preeminence. We are driven to succeed, to outperform everyone else, to win, and to prosper. So when someone else gets the promotion, gets the recognition, or wins the award, we often battle resentment. It can happen in a million different ways. For some of us, it just takes someone beating us to a position in a grocery line or someone else getting a bigger piece of meat at dinner to make us feel slighted.

At home, at work, church or in any situation we can often feel like we're not being properly respected. And that may often be the case, at least in our minds. There's a story in the Bible along those lines in Luke 22:24-30 where the disciples were debating over who would be the greatest in the Kingdom. It was a jockeying for position that Jesus dealt with very directly by saying that to be great you must become the least. This issue goes all the way back to Adam and Eve who wanted to be more than God desired them to be so they ate the fruit and ushered in a destiny of sin and death for all mankind. The root issue in each case was pride. Pride is present in all of us and it's a continual battle that we have to fight. But pride will fester within you and rot you from the inside out if you don't control it. In the Beatitudes, Jesus said, "Blessed are the meek for they shall inherit the earth." Meekness isn't weakness. It's actually defined in the Greek as power under control. And Jesus exemplified that perfectly in coming to this earth as a servant, to suffer and die for all mankind. It's the complete opposite of pride and it's the model for all of us to follow.

It's interesting to consider the impact of a police officer's presence to the general public. You have a badge, authority and weapons and they, hopefully, have none of these. How you choose to exercise that position of prominence and power makes all the difference in the world on how you are received. I've often reflected on the fact that so much of a police officer's job is really public relations oriented. Being perceived with meekness and as a servant will usually automatically deescalate the situation and open up the potential communication and relationship.

In this Luke 22 passage, Jesus tells His disciples to not worry about their position, their power, their prominence, or their prestige. He tells us that to be first in the Kingdom, we must become a servant to all. The truth of the Kingdom often seems to be in direct contrast to our normal worldly wisdom. The Lord tells us that the way up, is down. The way to gain prominence in the Kingdom is to have a servant's heart and to serve others here on earth.

And isn't that role of a police officer, when performed with the proper heart and mind? It's to fulfill this biblical mission day in and day out in service to the least and to the greatest in our community. And that has been so wonderfully displayed in the HBPD's outreach and assistance to the homeless. Having a duty and a heart to protect and to serve is a great calling and privilege, but it's also a great responsibility. It's interesting to consider that the words that everyone desires to hear as they breathe their last breath on earth are the words, "well done good and faithful servant...enter into the joy of the Lord." (Matthew 25:21) May the Lord give you His grace and help in being a servant to all.





HBPD Air Support Unit Honored

On Thursday, January 12, 2017, MD Helicopters, Inc. (MDHI) celebrated Huntington Beach Police Department's Air Support Bureau with a special commendation for its outstanding record of over 70,000 accident free flight hours.

Since its inception in 1968, the Huntington Beach Police Department's Air Support Bureau, known by residents as "HB-1", has patrolled the skies keeping an eye on the community and our police officers. Six pilots, one sergeant pilot, and two mechanics support the fleet to ensure 7-day-a-week availability to the cities of Huntington Beach, Costa Mesa, and Newport Beach.

Decades of experience, thousands of hours of flight time, combined with meticulous maintenance on the helicopters, has contributed to the Air Support Bureau's accident free record.

The Huntington Beach Air Support Bureau began flying MDHI-model helicopters in 1984 with the iconic MD 500E. The department acquired its current all-NOTAR fleet of three (3) MD 520N helicopters between 1992 and 2002. Designed to reduce noise by an average of 50% versus helicopters with tail rotors, NOTAR-equipped helicopters are among the quietest helicopters available worldwide.

The air crews of HB1 will continue their dedication to keeping the city safe from the air and to our future of accident free flying.



FAREWELL TO HEROES

On October 18th, 2016, Detective Austin and I jumped into a black and white and drove out to Palm Springs to celebrate the lives of fallen Officers Gilbert Vega and Lesley Zerebny. They were assassinated by a cowardly career criminal determined to make a name for himself as they answered a call for service. Killed because of the uniform they wore. A uniform that resembles the one we proudly wear every day when we work and a uniform that resembled the one worn by tens of thousands of officers who would assemble at the Palm Springs Convention Center this day.

Detective Austin and I were soon in a Huntington Beach Police procession consisting of Detectives Lewis and Gaska, Officer Grannis, Motor Officers Himert, Gallant, and Chen.

Before we left Huntington Beach, we made a plan to stop in Beaumont to give the motor officers an opportunity to stretch their legs after the long motorcycle ride and grab a cup of coffee. As we walked through the front door of Starbucks, we were greeted affectionately by several customers who knew where we were going and why we were there. A beautiful young woman paying for her morning coffee looked back at us and told the cashier as we walked through the door that she would purchase coffee for all nine of us. Of course we told her it was unnecessary and we appreciated the gesture. She insisted and as we gratefully accepted and drank our coffee, many patrons shook our hands and hugged us. They thanked us for the job we do every day and reminded us that the majority of hard working Americans appreciated us. As we sat down, Officer Himert who sat near the door hugged nearly every patron as they left.

After leaving Beaumont, we jumped back on the east bound Interstate 10 and eventually reached the service. Anyone who has ever been to a police officer's funeral knows how overwhelming it is to look at the hundreds of officers and their vehicles. This was much grander in terms of the sheer number of police motorcycles parked on the periphery outside of the Palm Springs Convention Center. Several

news helicopters flew overhead as we were guided to our parking spot. As we walked towards the convention center we saw Captain Bunetta standing near where our motor officers parked. There were several others including POA President Detective Humphreys that we were unable to find in the sea of blue, green and tan. It was great to see 10% of our small beachside police department represented.

When the service began, we were introduced to who the fallen officers were through their friends, family, and colleagues. We learned that Officer "Gil" Vega was a seasoned, tenured veteran and FTO who had actually trained the police chief when he was a new officer. We learned of his sense of humor and large family (he was one of 10 kids, with eight children of his own, 11 grandchildren and five great grandchildren) and being the son of a migrant worker from Texas who wanted a better life for his family. We heard from his well-spoken nephew who is a school principal back in Boston. He told us of a story when he was picked up by the LAPD after a night of questionable behavior. He said he found himself in the back of a black and white, being counseled in Spanish by a family elder (Uncle Gil) who told him if you want to work in public service you better clean up your behavior.

We were told that Officer Zerebny was a huge fan of the Canadian Tenors and their rendition

of "Hallelujah." The Canadian Tenors actually were so moved at hearing this story that they took time out of their busy schedule to honor her and perform live at the ceremony. It was said that she and her father (who is also in law enforcement) would sing this song at the tops of their lungs in their garage on his 5 acre desert property. This story was told to us by her father's friend who is also in law enforcement. We heard that as a young girl, Lesley Zerebny never wore shoes on the family property and would catch all sorts of animals including rats and snakes. She was eventually invited to her father and his friends camping trips. He said that she was the only female and could hunt and fish better than most men as she grew up. At a recent camping trip, the speaker said as he walked out of his tent with a cup of hot coffee, he saw a rattlesnake coiled up just outside the entrance of his tent. He said he immediately jumped back and spilled coffee all over himself, only to hear Lesley giggling from behind a tree nearby. It was then he realized the snake was dead and placed there coiled up to frighten him.

As Lesley grew up and blossomed into a lovely woman, the speaker said she drew the attention of many young men interested in dating her. He told us that he and others, who knew her well, knew the relationship was doomed when the new man started doting over her. Lesley, we were told needed her space. She found that space and the love of her young life, when she met her husband. As those of us in the audience listened to the Canadian Tenors perform again, we were treated to a photo montage of the Lesley, her husband, and newborn baby. The many outdoor hikes and adventures in the picturesque desert environment was beautiful and there was not a dry eye in the house.

As we left the ceremony, we decided to eat lunch before heading back to the station. While seated inside the restaurant, a couple sitting in the next booth started a conversation with Officer Austin and I. We learned that they were terribly sad to hear the horrible news and grateful so many officers had traveled so far to pay their respects. The husband was a former Marine and threw down a crisp \$100.00 bill and told us that lunch was on him. We gratefully acknowledged his kind gesture and told him that we could not accept it. They refused to take their money back, thanked us again and hugged us as they walked out of the restaurant.

On the drive home Officer Austin and I sat in traffic and discussed many things that all law enforcement officers know including the fact that the silent majority of the citizens we serve appreciate the hard work that peace officers put in every day.

In closing, I wear this uniform proudly and I am honored to serve with each and every one of you. Please be cautious in your duties and tell our civilian employees thank you for the jobs they do to support all of us. Remember as George Orwell said, "We sleep safely because rough men stand ready to visit violence on those who would harm us." Stay safe - stay vigilant.


